Enrolment in any or all subjects are available to the public, however, applicants must have passed CASA Commercial Pilot Licence (CPL) and CASA Instrument Rating (IREX) examinations prior to enrolment and we strongly advise that applicants hold a multi-engine class rating. Applications to enrol in any or all ATPL subjects must be done via completion of this form and submission to the Flying Operations Unit via mail, in person or email.
