UNSW Aviation delivers all CASA Air Transport Pilot Licence (ATPL) subjects at its Flying Operations Unit at Bankstown Airport typically over an 8 week period. Enrolment in any or all subjects are available to the public, however, applicants must have passed CASA Commercial Pilot Licence (CPL) and CASA Instrument Rating (IREX) examinations prior to enrolment. Applications to enrol in any or all ATPL subjects must be done via completion of this form and submission to the Flying Operations Unit via mail, in person or email. A deposit of \$200 is required to guarantee a place in the course and is not refundable within 28 days of the course start date.
